Bulgarian Government has advised all seeking shelter in Bulgaria to avoid private only arrangements and register as refugees officially. Currently there is no possibility to exchange Ukr Hryvnia (UAH) to Bulgarian Lev (BGN), it is therefore suggested to open a Bulgarian bank account to enable international money transfer.

# Travel:

Ukrainian citizens holding a biometric passport are able to enter Poland and travel freely within the Schengen Zone. Being considered as key workers, arriving seafarer currently do not need PCR test. A Locator Form to be filled-in before departure. If not, there is always an option to fill it in on board the aircraft.
